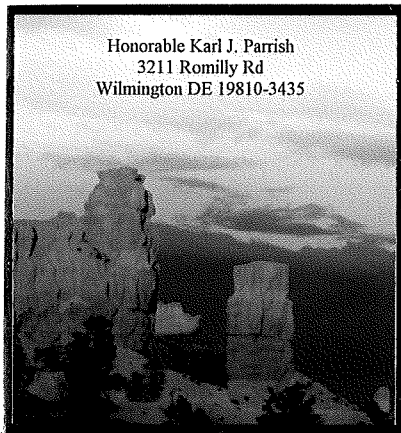

## INTRODUCTION TO VOLUME THREE

This is a listing of those men who served in the militia during the War of 1812. It was abstracted from the muster, pay and receipt rolls held by the National Archives and originally published by Family Line Publications in 1980 and from the Commission Book and other data found in the Adjutant General files of the Maryland State Archives. In this latest printing the earlier version of 1979 was scanned and notable corrections made. This volume will afford the user a virtually complete roster of those on active militia service allowing for a small portion of incomplete or missing rolls.

An extensive listing of Maryland militiamen was made by Louis Diehlman when he edited William M. Marine's *British Invasion of Maryland, 1812- 1815*. Diehlman added an appendix to Marine's narrative account of the war in which he listed alphabetically many of the Maryland militiamen. The rolls held by the National Archives were unavailable to Diehlman at that time. As a result less than half of the Maryland militiamen were included.

Remarks and annotations have been included which may shed light on the individual or his unit's involvement in the War. Remarks citing sickness or short periods of authorized leave have been omitted in most cases.

These abstracts have been organized regionally in order to aid the researcher in locating a particular veteran. Regiments and Cavalry districts were established according to county boundaries. The First Brigade of the Maryland Militia was made up of regiments from Cecil and Harford counties. Cecil County consisted of the 30<sup>th</sup> and 49<sup>th</sup> regiments and Harford consisted of the 40<sup>th</sup> and 42<sup>nd</sup> regiments. Cecil and Kent counties formed the 8<sup>th</sup> Cavalry District while Harford County and Howard's Troop from Baltimore County formed the 7<sup>th</sup> Cavalry District. The boundaries of the regiments within the two counties are unknown. Although districts were formed within counties coinciding with the regimental and company organizations, most of the descriptions of these boundaries have not survived. Clues to the general area of a company can be found in the annotations and by associating the names of the members with the 1810 federal census. In looking for a veteran in a particular county one should note that citizens sometimes crossed over county lines to enroll in a particular company. There were a number of men from Lancaster County, Pennsylvania who served with Harford and Cecil counties are included in this volume. There are also some citizens of Baltimore County who were assigned to the Cecil and Harford companies during the defense of Baltimore.

Determining a veteran's military service should normally be the first of two steps. The second step will entail examination of bounty land and pension applications. Bounty land acts were passed by Congress in 1850 and 1855; pensions were approved in 1871 and 1878. Applications and related correspondence are contained in files held at the National Archives. In these files you may find some or all of the following: military unit, place of residence, summary of military service, age, and in the case of the widow or other heirs, additional information may have been furnished such as: physical description of the militiaman at the time of his enrollment, date of his birth, date and place of marriage, names of former wives, date and place of veteran's death, names of surviving children, dates of birth of the children, and affidavits of acquaintances who attested to the veteran's military service, marriage and death. You may request copies of the files from the National Archives by mail. This volume will be useful in identifying the individual's military organization, enabling you to include the name of the captain and his regimental colonel or lieutenant colonel in the submission of your request. Abstracts of bounty land claims and pension applications of Cecil County veterans (and a few others from Harford County) are included in the latter part of this volume.

Sassafras Neck

Cecil County June 17th 1810

To His Excellency the Governor and the Honorable The Council of the State of Maryland ii Gentlemen,

Your favor of the 14th March last covering a commission constituting and appointing me Lieut. Colonel of the 49th Regt of Maryland Militia vice Col John Ward resigned, came duly to hand. I accept of this appointment and will endeavor to discharge the duties of the station in a manner that will [give] you no cause to regret the confidence you have reposed in me.

The organization of this Regiment I am sorry to say I found very defective -no company districts had been laid off, in consequence of which much confusion arisen among the officers in enrolling the men. In the Battalion under the command of Major Alexander no less than 6 sets of officers had been put in Commission when there were not men sufficient to make four full companies. Captain Johnson and his officers not being able to raise more than 18 or 20 men resigned their commissions in 1808 and Captain Bracen and his subalterns have since resigned. These resignations will enable me to lay off(f) the districts so as to divide their men between Captains Leach and Garret and make each of them I expect full companies which with Capt Mitchell's uniform company and Captain William Mackey's Rifle Company raised in part from the 30th Regiment will make four handsome companies attached to this Battalion. A fifth company I flatter myself, I shall be able to obtain from my friend Col Miller, who has at present 11 companies under his command.

In the Battalion late under the command of Major Josiah Ford Deceased, permission had been given to Capt Francis B. Chandlear, an ignorant, conceited, self important officer who commanded the West Sassafras Company, to raise a Light Infantry Company by volunteers from the Battalion and such(?) of the men belonging to the West Sassafras Company as declined joining him were dismissed and have never since been enrolled or mustered in any other company. I know not what to do with them unless I alter the Districts and attach them to Captain Pennington and Craddock's companies, an arrangement which I am well assured will be displeasing to them as they have always heretofore acted as a distinct company, and been indulged with officers of their choosing.

I conceive it proper to mention that since the formation of this Regiment in 1794 there never has been a Regimental Court Martial ordered, altho there has been repeated instances of violations of the law. At the meeting of the Regiment last September for Review and Inspection both Chandlears and Craddock (advocates for the British...) absented themselves with their companies because it was understood that General Smith was to be there, and were never called to account for it - Craddock has since my appointment, absented himself from the Battalion meeting on the 21st May last, for which I have ordered a Court Martial, and ...I shall either compel him to discharge his duty hereafter as an officer or resign his commission -The latter I would prefer, as he is too ignorant ever to make a capable officer Thomas W. "I take the liberty of soliciting information from you (Adjutant General of Maryland) on the subject of some disputes that exist in the Brigade between the officers of different corps. A considerable number of persons have attached themselves to the Cavalry companies since the last year Regimental returns were made, by which the apportionment of Infantry was struck but do not consider themselves liable to the infantry draught, which makes the requisition come much harder on the remaining infantry. Further, some of the persons alluded to, joined the cavalry since the General orders for the draught were issued, and even after the Brigade officers had drawn the apportionment for the different Regiments. Some of them indeed so short a time before the day on which the draught was ordered that the infantry officers were ignorant of it, and have actually draughted some of them as infantry. Are these draughts valid or not? I will only add that a new Troop ...within about a month or six weeks which has taken so many out of our company of Infantry that it will take nearly half the remainder to answer the requisition made; unless the newly made Troopers shall serve their tour of duty for which many of them are draughted. I am also directed to enquire of you whether, if any one company of Cavalry volunteers, to the number that may be required of the whole cavalry district to which it belongs, it will be received as the quota for the whole district. - I hope to have the honor of hearing from you as soon as convenient. - By order of Brigade Genl - John Gassaway, Esqr. Thomas M. Forman, Adjutant General. (signed) R. W. Armstrong Brigade Inspector, 1st Brigade - Elkton July 10 1812."

Brigade Orders -Hampstead Hill 4th Sept. 1814 The Supernumerary Officers of the 30th, 40th, 42d and 49th regiments and Extra Battalion are discharged after the 9th inst. and have now permission to return to their respective homes. But this discharge does not release them from certain important duties and that one to which they are to turn their attention is imposed by the Major General. They are immediately to collect and march to this place under the direction of a discreet officer all the drafts and volunteers of the First Brigade of Maryland Militia. In all cases of difficulty they must apply to the officer the highest in Command of their regiment or Extra Battalions and such Commander in case it should be necessary is to alone to call on the Commanders of Horse to aid and assist in bringing these men and all deserters to the camp at this place. But while this order is imperative it is strongly recommended that every Soothing and conciliatory method should be used before coercion is resorted to. The Brigadier General wishes the Gentlemen Officers a safe return and that they may find their families and friends well. By Order R. W. Armstrong, B. M.

The desertions which have been reported have before the Brigadier the most melancholy prospect of Seeing some of his fellow Citizens subject to all the penalties of the Military Law. Death is the penalty of desertion and the law acknowledges no distinction between men. The Commanders of the Regiment are directed to order out all strong Night Guards and to have their orders and Articles of War read to every Company.

## Bounty Land Claims and Pension Applications

In the following pages are listed abstracts of the bounty land claims and pension applications submitted by Cecil County veterans, widows and guardians on behalf of minor children of veterans. A portion of the claims submitted by Harford County citizens has been examined and included here. Also included are claims of some of the Pennsylvanians who served with the First Brigade of the Maryland Militia at Baltimore.

Most of the bounty land granted to the veterans of the War of 1812 was claimed under the acts of Congress enacted in 1850 and 1855. The bounty land warrants were usually sold on the open market; they were rarely exercised by the applicant. Because federal pensions were not granted until later, in 1871 and 1878, only a relatively few applications were submitted.

The following abstracts reveal genealogical information about the veterans, widows and minor children of the veterans; also mentioned are acquaintances who attested to the military service, marriage and death of the veteran. Appearing as witnesses were oft times relatives or neighbors who accompanied the applicant to the courthouse where the claim was submitted. Attempting to recall the names of officers after a lapse of 37 years or more veterans, and especially their widows, gave erroneous information. Stating the correct name of the company Captain was usually essential to obtain a bounty land warrant since the inability of the claims office to find the veteran's name on the rolls of the alleged Captain was sufficient reason to reject the claim.

To conserve space the following abbreviations are used:

acq -acquaintance(s) who usually attested to the veteran's military service. In the case of the widow's claim two acquaintances affirmed their marriage and her husband's death.

enr -enrolled

J. P. -Justice of the Peace

(N) - name not stated

o/a -on or about

res -resided or resident

wid -widow

wit -witness

Following the veteran's name in each abstract are a series of numbers representing: year of the act by which the applicant makes his claim - number of acres granted - arbitrary number of the veteran's file. "Rej" signifies that the claim was rejected. The cause for rejection was frequently the lack of sufficient service or the inability of the claims office to find the veteran's name on the rolls of the Captain as stated in the claim. Following the veteran's file number is the rank held by the veteran followed by the name of the Captain of his company as stated by the applicant in the claim.

After the Battle, and after the Bombardment of Fort McHenry & the retreat of the enemy shortly before the Md Election, our Regt being on Parade, it was announced from General Foreman that the Officers & Privates should have a Furlough for Ten days, that they might visit their homes, and exercise the right of suffrage in their respective election districts at which time it was further declared, that one Lieutenant & 14 men would be required as volunteers, to guard the arms & Camp Equipage, to whom a promise was made of a Furlough for two weeks, after the return of the rest of the Regt. Lieutenant Estep, immediately stepped forward, and I followed, knowing that I could not legally vote, being a minor, and lest some good Democrat, might be deprived of his vote by my going then, and the lengthened time by promise induced me to stay, and at the request of Lieutenant Estep, I acted as Orderly of the detachment, drilling and reporting daily, untill the return of the troops. Some short time thereafter, we made application to the General for our Furlough, reminding him firmly, though respectfully of his promise of the two weeks leave of absence; and strangely enough we were at first denied any furlough for any time, and when after much pressing solicitation he consented, would only grant one for eight days, far less than the main body of the Troops received. This was to us a great disappointment, and occasioned unpleasant feeling, and loss of confidence. I was then 52 miles from home by land, and 70 by water; it took about 4 days of the 8, to go and return. I cannot now certainly tell whether indisposition, or whether being detained at home awaiting the sailing from Elk Landing for Baltimore of a freight vessel, that kept me beyond the time of leave.. .To the best of my recollection, I never received even a reprimand, continued faithfully to serve in my place, and when the main body of the Troops were discharged, my brother, myself and a number of others were detached as Guards and went into Winter Quarters, were located in South Street near the wharf, there continued, untill discharged (without certificates) which was in November A. D. 1814...My

Brother Joseph is dead. John Short is no longer with us. Adjutant A. F. Henderson, my school mate, was killed by the explosion of the boiler of the Medora on her trial trip from Baltimore ... I met the enemy in company with perhaps 40 others at French Town, where the crews of 11 barges, proved too strong for our resistance, and which caused our retreat, without effecting anything. Shortly after, and before our march for Baltimore they returned with three barges up as far as the confluence of the two streams, Big and Little Elk which unite, between Elk Landing & Cedar Point on the opposite shore, being posted in Fort Hollingsworth, we recd. them with heavy ordnance, and drove them back to their shipping, which prevented the destruction of the Bay craft and warehouses & other property at Elk Landing. I beg leave also, to state, that, my youngest son David Porter, not then 17, entered the Army for Mexico, in Co. N, 2nd Regt of Pennsylvania Volunteers, ...was in the battle at the "National Bridge," "Churubusco," "Moline del Rei," who after escaping all the perils of actual war, took sick at San Angels, but under the Divine auspices returned home to the bosom of his sorrow stricken parents, emaciated and consumed, lingered until the 5th day of October 1848 and died with[in] 9 days of his 19th year ...like most of our Old Regular Baptist Preachers ...I could not write sooner, I could not write less ...." Signed Jesse Ash.
